

Adlumin Improves Network Health Score for Financial Plus Credit Union

Financial Plus Credit Union is a \$300+ Million Financial Institution

Financial Plus Credit Union (Financial Plus) is a statechartered credit union located in Illinois. Founded in May of 1951 by Charles Munks, with five offices and more than 32,000 members. Financial Plus is owned and operated by its members, who put their assets into various saving accounts. In return, that money can be lent to other credit union members.

Financial Plus is a reliable credit union that continuously strives to serve and provide complete coverage of its networks properly. The credit union sought an easy-touse <u>security platform</u> to support its IT team and make daily operations more manageable. Despite exploring different security solutions, the team found that many were missing key features desired in a platform, such as a 24x7 security operations center, threat intelligence portal, and continuous vulnerability management services.

Previous Solution Lacked Complete Visibility

The credit union was having visibility issues. Specifically, their security offering at the time did not receive alerts or give them the ability to manage and customize notifications within the dashboard. It became clear that Financial Plus needed a true security platform to help manage daily operations and allow users to customize alerts and reports.

A New Beginning Calls for Prioritizing Compliance

In 2018, Financial Plus learned about Adlumin while attending the <u>Credit Union National Association (CUNA)</u> <u>Cybersecurity Conference</u> with NASCUS in Nashville, Tennessee. During that time, the credit union sought a security platform to take their daily operations and network health to the next level. Adlumin became the MDR++ services platform and SOC to support the credit union's three-person IT team.





Provides Monthly Critical Reports and Customizable Notification and Alerts

The Financial Plus team scheduled an Account Manipulation Report, which they consider critical, to be delivered monthly. More importantly, Adlumin platform capability provides their board and IT committee with a designated report that includes an overview of key data points relevant to the organization's security objectives and needs. The Adlumin platform's dashboard alerts brought attention to specific elements of Financial Plus's network health that needed improvement. Each Financial Plus IT team members may customize notifications and alerts, which constantly keep them apprised of areas requiring special attention and/or further investigation.



Health Score Increased 20 Points

Within Adlumin's MDR ++ security platform, the network health score determines what factors increase risk in Financial Plus's network environment and offers users instructions through issue-specific icons on how to improve. That way, Financial Plus knows what action is needed to decrease each threat factor.

According to Adlumin's network health scoring breakdown, Financial Plus's current score is "excellent." After deploying Adlumin's MDR++ services platform in 2018, Financial Plus's initial network health score was

By the middle of 2020, their health score increased by 20 points, earning a health score of 95 out of 100.


